northern communities; and

WHEREAS: our resource sector relies on freight rail and changes in that service would

seriously impact our economy. Our existing highway network does not have the capacity to replace freight rail if cancelled or made economically

unviable:

NOW THEREFORE BE IT RESOLVED:

that the Council of the Township of Nairn and Hyman petition the Legislative Assembly of Ontario to immediately suspend plans to divest from the Ontario Northland Transportation Commission (ONTC) and consult with local municipalities, stakeholders and regional economic development organizations regarding the long-term plans for improving the effectiveness of the ONTC as a government asset;

AND BE IT FURTHER RESOLVED:

that this resolution be forwarded to the Premier of Ontario, the Honourable Rick Bartolucci, Minister of Northern Development and Mines, Michael Mantha, MPP, Algoma Manitoulin and Federation of Northern Ontario Municipalities.
