

MEMORIAL WALL FOR CANADA'S FALLEN SOLDIERS

AND PEACEKEEPERS

WHEREAS: Canada does not have a public memorial wall listing the names of all Canadian soldiers and peacekeepers who have lost their lives for our Country; and

WHEREAS: over 115,000 soldiers and peacekeepers have lost their lives and are buried in 75 foreign

lands, 40,000 of these have no identified graves and are marked "Known to God"; and

WHEREAS: a suitable national monument to our fallen military would show proper recognition and gratitude for their sacrifice;

NOW THEREFORE BE IT RESOLVED: that the Council of the Corporation of the Township of Nairn and Hyman request the Government of Canada to enact Private members Bill C-417 being "An Act to Establish a Memorial Wall for Canada's Fallen Soldiers and Peacekeepers" and that copies of this resolution be forwarded to the Honourable Stephen Harper, Prime Minister for Canada, Carol Hughes, MP for Algoma-Manitoulin-Kapuskasing and the Honourable Erin O'Toole, Minister of Veterans Affairs Canada.

The association and its chapters share common goals of providing information and education, supporting research, and advocating for programs and services for the autism community;
