

OWNSHIP OF NAIRN AND HYMAN BY-LAW NO. 2013-24

BEING A BY-LAW TO ESTABLISH FEES AND CHARGES TO BE COLLECTED BY THE CORPORATION OF THE TOWNSHIP OF NAIRN AND HYMAN

WHEREAS the Municipal Act, 2001, S.O. 2001, provides that a municipality may pass by-laws imposing fees or charges on any class of persons; and,

WHEREAS the Corporation of the Township of Nairn and Hyman deems it expedient to update the fees and charges to be collected by the municipality,

NOW THEREFORE the Corporation of the Township of Nairn and Hyman hereby enacts as follows:

- 1. Council hereby establishes the fees and charges as set out in Schedule "A" to this by-law for the Corporation of the Township of Nairn and Hyman. The fees and charges will be subject to the Harmonized Sales Tax (HST), where applicable.
- 2. That this by-law shall repeal By-law number 2007-7 and any other by-laws that may be inconsistent of the provisions contained herein.
