**TAKE NOTICE** that the Council of The Corporation of the Township of Nairn and Hyman will hold a public meeting on the 8<sup>th</sup> day of November 2021, at 7:00 p.m., at the Township Office, 64 McIntyre Street, Nairn Centre to consider a Consent Application under Section 53 of the *Planning Act*.

**PURPOSE OF THE APPLICATION:** The applicant has submitted an application for consent to add approximately 0.13 ha (1,301.7 m<sup>2</sup>) of land from PT LT 53 PL M40 PT 1 53R18593; NAIRN AND HYMAN (128 Minto Street) to PT LT 53 PL M40 PT 2 53R18593 (114 Minto Street). No new lot is being created. The proposed severed lot to be added to the abutting property is approximately 0.13 ha (1,301.7 m<sup>2</sup>) in area with about 58 m of frontage on Minto Street. The proposed retained lands will have a lot area of about 1.9 ha (19,668.3 m<sup>2</sup>) with approximately 322 m of frontage on Minto Street.

The Subject Lands are not subject to any other application under the *Planning Act*.
