CONSIDERATION OF INTERGRITY COMMISSIONER RECOMMENDATIONS RESOLUTION # 2022-8-139

WHEREAS a request for inquiry was made to the Integrity Commissioner alleging that Councillor Gingras had contravened the Township's Code of Conduct;

WHEREAS an inquiry was conducted by the Integrity Commissioner in response to the request and a report was presented to Council on June 13, 2022;

WHEREAS the Integrity Commissioner found that Councillor Gingras did violate Section 6.1 the Township's Code of Conduct, which states that "Every Member shall conduct himself or herself properly and in a civil and respectful manner at meetings", when she did make an unknowingly false and potentially embarrassing comment towards an ALPG executive at the November 8, 2021 Council Meeting;

WHEREAS the Integrity Commissioner found that Councillor Gingras did violate Section 6.2 the Township's Code of Conduct, which states that "Members will respect the decision-making process. Members will attempt to accurately and adequately communicate the attitudes and decisions of Council, even if they disagree with a majority decision of Council", when she spoke against a decision of Council;

WHEREAS the Integrity Commissioner found that Councillor Gingras contravened the Township's Council Proceedings By-law, sections 18.1 and 30.5 when she pursued a subject not currently under debate, and when she refused to support a Council decision once it was made;

WHEREAS Council has considered the findings and recommendations of the Integrity Commissioner:

NOW THEREFORE BE IT RESOLVED THAT

a) Council suspends Councillor Gingras' remuneration for a period of fourteen (14) days, for her contravention of the Township's Code of Conduct;

AND FURTHER THAT Council directs that a mandatory training session be required following the fall election, concerning the Municipal Conflict of Interest Act, the Code of Conduct and the Council Proceedings Bylaw for elected Members and senior Administration Staff.
